**FCCA Membership Meeting 11/16/2016**

Anthony McElwee, Second District Police Officer, reported on recent crime and traffic statistics.

Crime Report: There was one less crime reported than in the previous thirty day cycle. Thefts from autos continue to be the major crime. Officer McElwee suggested that garage door openers be removed from cars and all packages be taken from the front of houses.

Traffic Report: Officer McElwee issued twenty-seven tickets to drivers traveling in the left hand lane south on Foxhall Rd. who had ignored the "Left Turn Only" sign on Reservoir Rd. and continued southward.

Bob Avery, FCCA President, conducted the annual Board election. Standing Board members except for Karen Volker and Andrea Ramirez were reelected. Leo Blyth was elected to the Board with an area of interest for young families and social events.

The Georgetown Campus Plan was discussed. To help summarize the issues, here is the following explanation by Brady Holt as discussed in the 10/20/2016 issue of the Georgetown Dish:

"The university, with community support, was asking the DC Zoning Commission to simultaneously consider two aspects of its campus plan application: the full plan, which broadly covers the university's development and operations over the next 20 years; and a "further processing" decision that would allow actual construction

to proceed immediately on a long-planned addition to the hospital. The latter reflects specifics about the new building rather than just the general outline included in a campus plan.

The Zoning Commission has previously granted campus plan and further processing applications concurrently, notably to American University. But community opponents around that Ward 3 school said the commission had approved too much without granting adequate time for review, and they successfully lobbied for a rule change — which just went into effect last month as part of a broader zoning regulations rewrite. Now, universities can apply for further processing only after their more-general campus plans have won approval.”

Bob Avery clarified that there will be caps on parking, student enrollment, and building as part of the new campus plan. Bob stated that the FCCA had secured several concessions e.g. no buses on the loop road, 244 beds moved back on campus (equivalent of 50 group houses), helicopter pad will move away from entrance #4. A zoning hearing on the campus plan, without the further processing of the hospital project, is now scheduled for Dec. 1. A vote in support of the plan keeps the FCCA at the table for future debate. After a thorough discussion, Howard Bray suggested that the University meet with the FCCA annually to update the community on their campus and hospital plans. A vote was called, Mr. Bray's stipulation was included, and the members present voted 50 to 3 to approve the motion to support the campus plan as filed. A discussion of the hospital further processing plan will take place at the January FCCA Membership meeting.

Mayor Muriel Bowser was introduced and she in turn introduced her Deputy Mayors. Mayor Bowser articulated that her three top priorities are: focus on affordable housing; search for a new Police Chief; search for a Chancellor of Schools.

In response to questions from the audience, Mayor Bowser also commented on the following issues:

**Schools Report:** In addition to the search for a new Chancellor of Schools, attention needs to be given to the fact that the population in DC schools has increased. Graduation rates have also increased.

**Fillmore Arts Center:** She stated that she did not have an answer tonight. A change is warranted because there is a need to equitably fund all schools' arts programs. She is waiting on a proposal.

**Airplane Noise:** On 09/15/2016 the FAA met with members of the community at the Georgetown Library. As a result of this meeting, there were over 800 comments sent into the FAA. The next meeting will be 12/15. Mr. Tommy Wells, Director of the DC Department of Energy and Environment, discussed the bids that are out for solicitation to complete a noise study. \$260,000 has been allocated for the study. FAA will deliver their comments after the study is completed. The Mayor's office will share the results with the DC citizens.

If you will be driving to the meeting, be sure to park in the parking lot behind the building, accessed off Ashby Street—not on MacArthur Boulevard, Ashby Street, 49th Street, or any other neighborhood street.

## 2016 FCCA Treasurer's Report

### Income and Expenses

The following report presents the FCCA's unaudited statement of operating income and expenses for 2016. This year's income of \$9,667 included an increase in dues by 2.6 percent from 2015, which included continued growth in online payments made through Paypal. Interest income declined from 2015 due to lower interest rates paid on the FCCA's two laddered certificates of deposit. The major expenses were for the newsletter and printing; the stipend for the FCCA administrator; community events; the FCCA website; and Paypal fees. Other expenses included the biennial DC corporation tax and office supplies and postage. The FCCA added \$1,383 to its Capital Reserve in 2016.
