



January Meeting Update

The January 16th general meeting of the FCCA will feature a presentation by former Palisades ANC Commissioner Alma Gates on pending DC zoning changes and their potential impact on our neighborhood. The District office of Planning has recently proposed a major reorganization of the District's zoning code which is designed to make the regulations easier to use. Alma is particularly knowledgeable about the implications of these changes as she serves as the Chair of the Zoning Subcommittee of the Committee of 100 of the Federal City. These changes are only at the proposal stage so if we have concerns, now is the time for us to voice them.

We will also hear from our two new ANC commissioners at the January meeting. Gayle Trotter has replaced long-time ANC commissioner Ann Haas who retired from her position as ANC 3D-09 single district member representing much of the FCCA neighborhood. Ann served for over 8 years as a relentless advocate for the interests of our area. Her shoes will be hard for Gayle to fill! Penny Pagano, former president of the Palisades Citizens Association, was elected on a write-in campaign to represent the other ANC district which overlaps the FCCA boundaries. Penny was initially elected to fill out the term of retiring long-term ANC commissioner Ann Heuer and was just re-elected. Both new Commissioners will briefly talk

about their visions for the ANC and introduce themselves to us.

The January meeting will also feature our regular police report and an update on the German embassy renovations.

FCCA Board Elected, New Members

At the November membership meeting all existing Board members except for Tom DeMuth were re-elected. Tom is stepping down after several terms as a board member. We will miss him and his valuable role in the thankless task of setting up for meetings and helping maintain our membership log. Two newcomers will be joining the Board--Joseph Williams and Peter Kimball--both of whom live on 44th street. Welcome aboard!

At its December 4th organizational meeting, the Board voted to continue its current governance structure, whereby most Board decisions are made by votes of the Board as a whole rather than organization officers. The current Board officers, Bob Avery as president, Hulit Pressley Taylor as treasurer, and Jessie Kane as secretary, were re-elected for another one-year term.

German Embassy Update

The German Embassy has provided (below) an update on its construction work at the German Embassy and Annex. They have also accepted our offer to attend the January 16 meeting to answer any questions community members may have about the work at the embassy. We have had some complaints recently about some littering that is occurring (we think by the construction workers) and construction workers parking illegally (either for too long or blocking driveways). These complaints were raised with the German Embassy, which acted expeditiously to raise the complaints with the contractor in charge of the project. In addition, we requested that DC Department of Public Works patrol the area and ticket illegally parked cars more aggressively, which they have since done. German Embassy Construction News

The demolition works have been completed and all hazardous materials have been removed safely according to U.S. building and construction regulations. As of November 2012, the construction company has finished the preparatory work as well as certain repairs such as fire protection in the chancery building. The contractors completed the installation and fitting of most of the windows from Germany. Interior works have already started with dry wall and some rough-in installations and will

go on soon as the building has been sealed and prepared for the winter season. Also the works in the annex buildings are under way and progressing.

The Embassy has not been alerted to any major inconveniences or noise pollution and is pleased to report that it was able to promptly resolve minor problems. The administration of the Embassy weekly reminds its contractors of the need to observe traffic regulations, be respectful of our neighbors and keep the neighborhood clean. NPS Evicts Jack's Boathouse; Status on Hold

On December 18th, the National Park Service alerted Jack's Canoes and Kayaks LLC, more popularly known as Jack's Boathouse, that the business would need to leave the space it was renting from NPS by January 31st. Jack's Boathouse has been in operation near Key Bridge since 1945. NPS has jurisdiction over the boathouse, as the District government transferred that portion of the waterfront to the agency in 1984.

Immediately after the announcement, Jack's received a significant outpour of support from customers and enthusiasts. Based on that backlash, NPS agreed to review its decision and suspended the eviction. Despite the delay, the outcome for owner Paul Simkin's business, as well as the employment of the 27 staff who work there, is unclear.

Foxhall Village Historic District is on the Map!

Some of you may have already noticed the brand new street signs announcing The Foxhall Village Historic District. These handsome markers, at the end of each street in the district, were a gift to the neighborhood from the District of Columbia Historic Preservation Office and DDOT. Long a fixture in other historic districts, like Dupont Circle and Capitol Hill, these signs at all the major intersections in the community now proudly mark the city's westernmost historic district.

And that's just the beginning of the good news for Foxhall Village preservation. In the Autumn of 2012 the DC Historic Preservation Office released The Foxhall Village Historic District brochure. Part of a program to preserve the history of each historic district, this brochure details the early development of our unique neighborhood. Based in part on research done for our application in 2007, the brochure includes period photographs, historical maps, architectural drawings, even early advertisements for homes for sale in the neighborhood.
